Good morning Mohammad.

Tonight we had Mayor Rob Ford on site with Isaac Ransom, Brooks Barnett, Earl Provost and Olivia Gondek. Mayor Ford was driven to City Hall by a friend of his at around 2030 hours. He stated that he left his access card at home and requested a temp card. We issued one to him at approximately 2100 hours. Between 1900 hours and 2300 hours, I worked with S/O Jen Braybrook. At 2300 hours, S/O Rod Woodman started his shift. The Mayor and his entourage headed up to the Mayor's office for a few hours before heading out at around 2310 hours. He returned to City Hall at approximately 0200 hours, accompanied by Brooks Barnett and Earl Provost. It was quite evident that he was very intoxicated as he had problems walking, was sweating profusely and was swearing at Provost as he walked by the Security desk.

At approximately 0220 hours, the gentleman who dropped off the Mayor requested access to his vehicle in OFFICIAL PARKING (parking spot #1), he was accompanied by two unknown females. I provided access to the area so that he could depart and he did so.

At approximately 0230 hours, the Mayor headed down and visited the Security desk alone with a half empty bottle of St-Remy French Brandy. He proceeded to make comments about how "they" stole his car and that he was going to call the police. S/O Braybrook and I kept the Mayor company outside the main entrance as he requested that he wanted to leave.

We offered to call him a cab in order to make sure he got home safely but he refused. I reminded the Mayor that he did not drive to City Hall and that his car was safe and sound at his place of residence. At this time, he realized that nobody had stolen his vehicle and disregarded the idea of calling the police and headed back inside. I took the bottle of french brandy from him and set it aside.

At this time, S/O Braybrook kept him company in front of the Security desk as I headed up to his office to check and see if any members of his entourage were present. There was nobody in the Mayor's office. As I returned, S/O Braybrook was with the Mayor along with Provost, Gondek and Ransom. The Mayor requested to go outside and we accompanied him. Due to it being St. Patrick's day, it was evident that there were a lot of intoxicated people on the streets, so I went over to Bay St. and flagged down a taxi as S/O Braybrook stayed with the

At approximately 0250 hours, we managed to get the Mayor in a cab and off to his place of residence. Earl

Gondek and Ransom stated that they appreciated our assistance and that we could get rid of the bottle of brandy. The temporary card issued to Mayor Ford (#98622) was returned to me by him but later Isaac Ransom requested to hang onto it for the Mayor. The card is active until Tuesday March the 20th at 2359 hours. The Mayor earlier had informed me that he left his card at home but wasn't sure where it was.

Due to the nature of the incident involving the Mayor, we will not be submitting any reports but hopefully this email will suffice. Overall, the Mayor was quite pleasant towards Corporate Security on this night. Though it was quite evident he was upset and on a couple occasions started to yell and swear ("fuck this guy", "fuck you", etc) and made some very alarming allegations regarding
